Did you know that AzOWRA has several presentations and education programs ready to deliver to interested parties around the state?

Our Realtor Education program is approved for 3 hours of continuing education by the Arizona Department of Real Estate. Lowell Fagen, long time REALTOR[®] in Arizona, and Edwin Swanson, PE are the approved instructors for this course. This program educates the real estate agent about her responsibilities when the property to be sold has an onsite wastewater system. The course goes through the specific requirements of the ADEQ required Transfer of Ownership inspection and submittal of the Notice of Transfer forms. The program includes what is a well done inspection and what to do if the inspection brings up unexpected information about the system. This program is presented during the AzOWRA Conference but can also be presented at Area Realtor Associations around the state.



The Homeowner Septic Education Course has been presented three times in Yavapai County. We have trained nearly 350 homeowners about how their septic system functions and how to operate and maintain it for long life. This program was recently recorded by a videographer. We are hoping to make the presentation available over the internet and lending libraries. Yavapai County provided for a testing audience to develop and refine the presentation. We are looking forward to making it available statewide.

The newest release is a Member Recruitment PowerPoint first presented in Tucson. This program is ready to be taken to interested groups such as Contractors' Associations, designer groups, Pumper associations and other interested groups around the state.

Septic Locator

"What is the Septic Locator," you ask? It is one of the most under used benefit of your AzOWRA/NOWRA membership. The Septic Locator is a nationwide searchable database which allows you and your customers to connect. There will be a demonstration of the information available during the Membership Meeting on November 13 at Heidi's (see article on page 2). Initial profiles are created by AzOWRA when your membership application is accepted. Then you need to update the information so it is current and rele-

vant. A question that is always asked at the Homeowner Septic Education programs is, "Where can I get a good service provider (pumper, installer, designer, etc) to work on my system? The Homeowner's manual and the program direct people to the NOWRA and NAWT websites, as well as Registrar of Contractors, neighbors and the Better Business Bureau to help find qualified practitioners. The really cool thing is that they **are** going to the Septic Locator and **calling** AzOWRA members!





Membership Applications/Dues Needed January 1, 2010
